The insurance premium for this plan is paid 100% by the University Graduate School while receiving your fellowship stipend. If applicable, when you begin your assistantship while being a fellow, you are expected to pay 25% portion of the insurance premium (as required of all GA/TA/RAs) once hired by the Department.

****Fees** – All fees listed are based on the 2017-18 academic year and are subject to change.

Taxes – Fellowships used for living expenses are subject to U.S. taxes. (If you are an international student, the University is required to withhold taxes on the portion of the fellowship used for living expenses unless there is a tax treaty between your country and the United States. The taxes will not be deducted from the fellowship but rather posted on your student account as a tax charge. You will be required to pay the charge by the final day to pay deadline for each semester.
